Minutes - Vienna Selectmen's Meetings

May 15, 2001

The minutes of the last meeting were approved as read. Fire Chief Jon Ljunggren expressed his hope that the upcoming Fire Truck Referendum vote would pass. He said he was not willing to compromise the safety of his firefighters.

It was reported that the proposals for Cemetery Lot Clearing job were opened on May 5th. The job was given to Randy Carl. He reported that he was unable to burn the brush piles at this time. He will use a chipper for the first of the piles.

A Rabies Vaccination Clinic with Dr. Cooper has been set for May 26th from 1:00 to 2:30 p.m. at the Community Center. The town clerk will also register dogs at that time.

Al reported on a meeting on Historic Preservation that he attended. The discussion stressed the importance of preserving historical buildings such as our Town House.

The cemetery committee has completed a draft of the rules and regulations for the Vienna Municipal Cemetery. Copies are available at the Selectmen's office.

Warrant #10 was prepared and signed. The meeting adjourned at 10:00.

June 5, 2001

The minutes of the last meeting were not available. Richard Nystrom, Jr. requested abatement papers for his property.

Randy Carl, Animal Control Officer reported on his first rabies clinic. He reported that the clinic was a success and with one year's experience under his belt, he assured the Board that next year's clinic would be held much earlier in the year. Mr. Carl also reported on the condition of the dog that had been three times bitten by a beaver. The dog remained in home quarantine, under Mr. Carl's supervision, and it had shown no signs of illness or distemper.

Mr. Carl reported, as well, on his progress with the tree work on the Town's Cemetery lot, which has been delayed by his not having had days in which to burn the tree and brush piles. He has had difficulty obtaining a permit to

burn from the Fire Chief, due the continuing lack of rain and the dry conditions on the land.

The Board of Selectmen then discussed the issue of a business property tax for the Town of Vienna. The issue has been raised to the Board, and it has agreed to look into the matter with the State. The Town has never assessed a business property tax in the past, although a personal property tax is mandated in state law. Nonetheless, the state now has a local business property tax reimbursement program to encourage local business, which may make the assessment of a local business property tax feasible. The Board will continue to look into the issue of a local business tax. It appears to be an appropriate subject for a town-wide information meeting and discussion, when the Board has had a chance to better inform itself.

The Board also discussed the possibility of painting both the roof and the outside of the Town House this year. If some money can be found in the total raised and appropriated for building repair at the Town Meeting, and it is added to the amount that remains in the Town House account, both tasks might be accomplished this year. Both certainly appear to the Board to be necessary.

The Board agreed to hire someone to clear the files and furniture out of the Selectmen's office, so the restoration work on the plaster walls and ceiling can be started.

Warrant # 11 was prepared and signed. Mail was opened and read. The meeting adjourned at 9:30 PM.

June 19, 2001

The minutes of the last two meetings were approved as amended.

Road Commissioner Dan Goucher reported that he received two price quoted for the paving project on Tower Rd. Blue Rock's quote came in lower than Pike Industries. Dan will negotiate the price with Pike who has worked on the project for the last two summers. Dan will have damage waivers for property owners who want to accept fill created by ditching.

James F. Meader notified the selectmen of his intent to subdivide a property on Tower Rd.

He will meet with the planning board at their next meeting.

ACO Randy Carl reported on three animal situations that he has responded to in Vienna.

The town boat is being serviced for the season at Belgrade Lakes Marina.

The selectmen discussed the town house roof-painting project. This will be put out for proposal. The furniture will be moved out of the selectmen's office, making way for the renovation by Lionel Laliberte.

The selectmen received the 2001 – 2002 assessment of the SAD #9 Tax. Vienna's share is \$329,981 for the year. The monthly payment is \$27,498.38. (Last year's payment was \$26,044.92.)

There was a discussion of the renewal insurance policy that covers the town boat. Al will talk with Keyes Insurance about the coverage.

Warrant #12 was prepared and signed. The meeting adjourned at 11:00 p.m.

Work Session: June 23, 2001

Pat Wheeler of Pat's Burner Service volunteered to help the selectmen move everything out of the small office during the work session on Saturday.

July 3, 2001

The minutes of the last meeting were approved as amended. The selectmen received the assessment for the 2001 Kennebec County Tax in the amount of \$34,954.46.

It was reported that Creston Gaither d.b.a. York Hill Surveying has completed the boundary map for the Municipal Cemetery at a cost of \$339.

This year's licensing and support fees for the Tax Collector's and Town Clerk's Trio Software is \$752.50.

Dodi reported that Maine Equalization has completed the 2001 pick-up work. All property cards have been returned to the town house. The tax maps have been updated by Creston Gaither to reflect this year's property transfers. The selectmen and tax collector will now update the records on the cards and in the computer and prepare for the 2001 tax commitment. Tax bills should go out in August.

Warrant #13 was prepared and signed. The meeting adjourned at 9:00 p.m.

July 17, 2001

Minutes of the last meeting were approved as read. Al Raedle reported that he and Charlie Meader along with Road Commissioner Dan Goucher met with Dave Ames of the DOT concerning the placement of a new driveway on Jesse Ladd Rd. Dan and Marie Repetti, future owners of the lot in the JAE Realty subdivision were here to discuss the situation with the selectmen. They agreed to place the driveway in a location that would not interfere with the established run-off on the road because of environmental concerns.

Dan reported that the work on Tower was once again awarded to Pike Industries.

There was a discussion of the winter salt and sand for the upcoming season. It was agreed that the job would go out to bid by late August.

Phil Gregory spoke to the selectmen about the importance of computer security and virus protection.

Fire Chief Jon Ljunggren reported that more volunteer firefighters are needed by the town. There will be no Fire Department Chicken Barbecue this year due to low manpower and low morale in the department. There was a discussion on the situation

the town is in by having one fire truck only.

Randy Carl reported on several calls that he responded to as Constable and ACO. He also gave a progress report on the cemetery clearing.

The selectmen will be having a work session with the tax collector as soon as possible to enter the 2001 valuation and name changes.

James Ellis told the selectmen that was planning to buy the Peter Tyler property across from the town house. He made inquiries about tree growth laws and other issues.

Brian Dreher stated that he was planning to buy three lots of the Jesse Ladd Rd. subdivision. He also discussed tree growth and other property issues with the selectmen.

Warrant #14 was prepared and signed. The meeting adjourned at 10:30 P.M.

The minutes of the last meeting were approved as amended. The town has received approval from the Department of Human Services for the new municipal cemetery. Al reported that the cemetery committee would be meeting on Monday to finalize the initial gridwork of burial plots and roads.

The town has received the results of the State Audit of our money handling practices. The selectmen will set up a meeting with the town clerk, the treasurer, and the tax collector to discuss the findings. The state offered suggestions on better checks and balances in all areas of money handling.

Signs will be posted on Tower Rd. by the boat ramp on Parker Pond stating that the ramp is not maintained by the town and usage is "at your own risk".

Fire Chief Ljunggren brought by fire insurance information brochures from ISO. They will be available at the town house and the community center. Chief Ljunggren reported that the Fire Department is mailing out postcards asking for volunteer firefighters.

Warrant #15 was prepared and signed. The meeting adjourned at 9:00 p.m.

August 21, 2001

Minutes of the last meeting were approved as read.

Fire Chief Ljunggren and the selectmen discussed the pros and cons of used fire trucks and new trucks.

The selectmen have opened an account with Hammond Lumber Co. for paint and other supplies.

Dan Goucher discussed the Anderson Rd. project. Al reported on his discussions with Mark Hedden and MMA. Dan reported that the Tower Rd. project would be started this week. Ervin Bean will mow the roadsides for a cost of \$1400.

The selectmen resented an earlier decision and voted to buy the winter sand from George Tibbetts, and give the job of hauling and putting up to the Road Commissioner.

Randy Carl gave his reports at Constable/Harbormaster and Animal Control Officer.

Warrant #16 was prepared and signed. The meeting adjourned at 10:00 p.m.

August 21 continued.

- ACO Randy Carl will be getting more Havaheart traps, which will be available to townspeople on a temporary loan.
- Sky Ludwig has completed the eave repair at the town house.
- Warrant #18 was prepared and signed.
- Meeting adjourned at 10:00 p.m.

October 2, 2001

There are no minutes available for this meeting.

October 16, 2001

Fire Chief Jon Ljunggren discussed the importance of keeping the hydrants clear of snow. He also reported that the Fire Department had been reviewing their Standard Operating Procedures concerning hazardous materials in light of recent events.

Road Commissioner Dan Goucher reported that Tower Rd is scheduled to be paved on Thursday or Friday. Dan, Chief Ljunggren and Randy Carl all reported on a serious injury accident that occurred while a Pike Industries employee, who had been working on Tower Rd., was loading his equipment. The Vienna Constable and Fire Chief, the Rescue Squad and others from Mt. Vernon, the State Police, and LifeStar Ambulance all responded. The victim was airlifted to Lewiston.

October 16 continued.

There was a discussion on the importance of the Road Commissioner always notifying the Constable and Fire Chief anytime a town road will be temporarily closed or any detour is in use.

The Dot has furnished examples of forms used for turnaround and drainage easements. "School Bus Turnaround" signs have been put up on Klir Beck Rd as well as a "Caution - Children" sign on Stream Rd.

Dan reported that he still has work planned for the Bessey, Stream, Jesse Ladd and Anderson roads.

Constable/Harbormaster Randy Carl will put the town boat into winter storage. He reported on recent calls he has received as Constable.

Dodi reported that the Mt. Vernon Rescue Squad has requested \$900 as Vienna's share of the new defibrillator. This will be taken out of surplus.

The selectmen signed the new three-year Ambulance Service Agreement with Franklin Memorial Hospital.

The board voted to adopt the new General Assistance Ordinance appendixes for 2001 - 2002. The adoption paper was signed and a copy will be sent to the Department of Human Services.

Warrant #20 was prepared and signed. The meeting was adjourned at 10:45 p.m.

November 5, 2001

Minutes of the last meeting were approved as read.

The selectmen discussed winter boat storage options with Constable/Harbormaster Randy Carl.

Town Clerk Connie Smith was preparing for tomorrow's election. This is a State Referendum Vote as well as a SAD #9 question. Connie, Ernestine Emery and Amber Emery were on their way to the Community Room to set up the voting booths, tables, ropes, etc. for the election. Polls will be open from 10:00 A.M. until 8:00 P.M.

It was reported that this year's Tower Rd project has been completed. Also, the winter sand/salt has been put up and covered with plastic.

Warrant #21 was prepared and signed. The meeting adjourned at 10:00 P.M.

At the meeting: Al Raedle, Charles Meader, Dodi Thompson, Connie Smith, Ernestine Emery, Amber Emery, Carolyn Raedle.

November 20, 2001

The meeting was held in the Community Room due to the floors being refinished in the Town Hall.

Town Clerk Connie Smith reported that the dog licensing tags for 2002 were now available.

Harbormaster reported that the town boat has been serviced for the winter and shrink wrapped by Great Pond Marina. It is being stored adjacent to the Community Center.

Road Commissioner Dan Goucher reported on work done on the Mountain Rd. A letter from Dianne Friese was read, concerning the bottom portion of Anderson Rd., which ends by the Hedden residence. Drainage easements are required from Mark and Carol Hedden before Dan can finish the project.

There was a discussion with Snowplow Contractor Lenny Meader about town roads and preparation for the upcoming season. The discussion included a review of last season and possible ways to improve this year's service.

A card was read from Betty White of the Mt. Vernon Food Bank thanking the Town of Vienna for the \$200 donation.

Brian Dreher talked to the selectmen about permits and paperwork for his property.

Plumbing inspector/Code Enforcement Officer John Archard was contacted by telephone on the matter.

There will be no selectmen's work session on Saturday, November 24 due to Thanksgiving. There are plans to move the furniture, etc. back in place at the Town House on Tuesday, November 27 at 8:00 AM. Randy Carl and a friend volunteered to move it out and will also move it back in. The selectmen will have work sessions during that day and at 6:00 P. M. that night to get things back in order. There will also be a work session on Saturday, December 1st at 10:00 A.M.

Warrant #22 was prepared and signed. The meeting adjourned at 9:30 P.M.

- Cemetery committee is discussing the fee schedule for lots and perpetual care.
- Kyes Insurance has notified the town that Peerless Insurance Co. is no longer writing the type of bond insurance that the town requires. Kyes will find the town another company before the current policy expires.
- Warrant #23 was prepared and signed. Meeting adjourned at 10:00 P.M.

At the meeting: Al Raedle, Dodi Thompson, Marti Gross, Jon Ljunggren, Rachel Meader, Irene Goff, Carolyn Raedle, Lois Brown, Gil Brown.

December 19, 2001

Minutes of the last meeting were approved as read. Al reported that he talked to Bill Hinkle of the DEP about the proposed pond on one end of the cemetery. Mr. Hinkle stated that the only requirement is that it be 100 feet from the stream.

Fire Chief Jon Ljunggren reported that the Smokey the Bear Fire Danger sign and the Town of Vienna sign, located at the Town Park had been vandalized. Both signs will be removed and hopefully repaired.

Chief Ljunggren reported that the fire truck went in for servicing. It will not pass inspection until four tires have been replaced. Jon said that there is enough money in the budget for the new tires. The current sticker is good until December 31.

The three dry hydrants need to be shoveled out a few times a winter beyond what the plow can do. This job will be done by Ernestine Emery, who also shovels the town house entrance and path and the Community Building.

Randy Carl reported that the last of his brush piles at the cemetery have been successfully burned. This completes the job that he contracted to do.

It was reported that the first burial had taken place in the Town Cemetery. The selectmen voted to set the price of lots at \$100 per lot plus \$100 for perpetual care for up to eight lots for residents and property owners. For non-residents who don't own property in Vienna, the price for perpetual care will be \$150 per lot. There was a discussion of possible plans for future cemetery landscaping.

December 19th continued.

Al reported that he is continuing his work on the handicapped access grant for the town house.

The selectmen and Road Commissioner Dan Goucher had a lengthy discussion of the Anderson Rd. project. Dan reported that although this year's portion of the project has been started, there is not enough money in the budget to pay for it in 2001, due to miscalculation on his part.

Several options were discussed:

1. A special town meeting now to request that enough money is taken out of surplus to finish the job.
2. Finishing the project in January and submitting the bills for the 2002 budget.
3. Over drafting the accounts for 2001 and ask that the overdraft be taken out of surplus at March town meeting.
4. Putting everything on hold until after the March town meeting.

Al will call MMA to see what our options are from a legal stand point and then get back to Dan as soon as possible.

Warrant #24 was prepared and signed. The meeting was adjourned at 10:30 A. M.

The first order of business was the Anderson Rd. project. Residents Mark and Carol Hedden, Diane Friese and Don Acorn joined the selectmen and Road Commissioner Dan Goucher in the discussion.

Al was told by legal at MMA that the only way the town could finish the job now to make plowing possible this winter, would be for Dan to donate the work (with a monetary value for labor and materials) as an unconditional gift to the town. Dan agreed to do this out of concern for the project and to avoid spring road damage. Al was advised by MMA that the selectmen have the option to submit an article at the March town meeting asking that Dan be reimbursed for his gift to the town.

To proceed with the job, it was agreed that Dan would take out the first maple tree and put a culvert under Hedden's driveway and a culvert under the turnaround. He will need a corrected drainage easement from the Heddens and a drainage easement from the Friese/Acorns. It was agreed that everyone would meet back here tomorrow night to finalize the paperwork.

January 2 continued.

Town Clerk Connie Smith filled out nomination papers for all the incumbents who were present. Warrant #25 and Warrant #1 were prepared and signed. The meeting was recessed until 6:00 P. M. the following night.

January 3, 2001

The meeting reconvened with the selectmen voting unanimously to accept an unconditional gift of labor and materials from Dan Goucher dba Dan Goucher Construction not to exceed the amount of \$7500 for the Anderson Road project.

Mark and Carol Hedden and Diane Friese and Don Acorn submitted their notarized drainage easement forms to the selectmen. The selectmen and Dan Goucher then went to Notary Dorothy Waugh's residence to sign the gift agreement.

The meeting was adjourned a 7:00 P.M.

No Parking Ordinance

Parking will not be permitted on the sides of town roads during snowstorms.

Parkers interfere with the work of snowplows and delay the clearing of Town roads for commutation and emergency vehicles.

A snowstorm, for the purpose of this ordinance, is defined as a storm on which a Town of Vienna snowplow is dispatched to clear roads.

Cars found in violation of this ordinance may be towed at the expense of the vehicle's owner. Roads must be kept clear during snowstorms as an issue of public safety.
